For each of the following select the correct answer. There is only ONE correct choice for each question. For any fouls that are not offset, assume that the penalty is accepted unless it is declined by rule.

- 1. When the ball has become dead at the end of a down, the Back Judge notices that B44's jersey does not cover one shoulder pad as a result of the play just completed.
- a. Illegal equipment. Team B is charged with a timeout and B44 must leave the game.
- b. Illegal equipment. B44 must leave the game but there is no charged timeout.

 - c. Both a and b are correct answers.

- 7. On the opening kickoff, B22 catches the kick at his goal line and returns the ball down the sideline on Team B's side of the field. As he moves down the sideline officiating the play, the side judge runs into a Team B coach or squad member in the restricted area ("the white"). B22 is driven out of bounds at the A-20.

- b. Automatic first down for Team A after enforcement of the 15-yard penalty. The quarter is extended for one untimed down.

- 26. Second and goal at the B-8 late in the fourth quarter. Team A trails by four points. Linebacker B55 intercepts a forward pass in the end zone and returns the ball to the B-12 where he is driven out of bounds. At the end of the down the game clock read 0:06. End B99 was lined up in the neutral zone at the snap.

- 27. Fourth and five at the A-45. Team A's punt goes out of bounds at the B-12, but the officials spot the ball at the B-7. The Instant Replay official may interrupt the game to review the out-of-bounds spot.

- 28. Late in the first half, ball carrier A22 is tackled inbounds and as he hits the ground his helmet pops off. Tackle B77 is on the ground with an injury. Team A has no timeouts remaining and Team B has one. When the down is over the game clock reads 0:45.

 - a. First and 10 for Team A at the A-35.
